 - AC 00-45G Change 2 final draft complete, awaiting AFS-1 signature
 - AC 00-45H Scoping phase. Planning late 2015 publication







Change 2 Focus

FAA decision to focus rewrite to Sections 1,2, and 9

- Very large document
- Limited FAA manpower
- Limited NWS manpower
- Arduous FAA internal coordination process
 - Including public comment period
- FAA focus on high priority items














Aviation Weather Product Policy

- Eliminate terms "Primary" and "Supplementary"
 - Already eliminated from the AIM Section 7-1 (4/3/14)
- Revised aviation weather product policy
 - "All flight-related aviation weather decisions must be based on all available pertinent weather products. As every flight is unique and the weather conditions for that flight vary hour by hour, day to day, multiple weather products may be necessary to meet aviation weather regulatory requirements."
- Updated EWINS general guidance









Area Forecast – new verbiage
"Area forecasts are not intended for use in
operational decision-making or as a
substitute for a TAF in 14 CFR part 121 Air
Carrier operations. In these operations, an
FA may only be used to enhance situational
awareness."






